## **FILING PERIOD FOR 2018 CANDIDATE NOMINATING PETITIONS BEGINS MONDAY, NOV. 27**

Kane County Clerk John A. Cunningham would like to remind Kane County residents that Monday, November 27<sup>th</sup> is the first day on which established party candidates (Republicans and Democrats) running for local county and precinct level offices at the March 20, 2018 general primary election can file nominating petitions.

Nominating papers filed in person at the Clerk's Office, 719 S. Batavia Ave., Building B, Geneva, IL will be accepted beginning at 8:30 a.m. on November 27. All candidates in line by 8:30 a.m. will be deemed to have filed at 8:30 a.m. and will be eligible for the lottery to determine ballot position.

The filing period continues through December 4. Petitions will not be accepted after 5:00 p.m. on December 4.

Local offices up for election include County Clerk, County Sheriff, County Treasurer, Regional Superintendent of Schools, odd-numbered County Board districts, and Precinct Committeeman. Petition packets, which include petitions, Statement of Candidacy, Loyalty Oath, Statement of Economic Interests, signature requirements, filing deadlines and other candidate information and forms, are still available online at the Kane County Clerk's website, <http://kanecountyelections.org/UpForElection.aspx>, and at the Clerk's Office.

"The first day of the filing period is an exciting day, especially for first time candidates. The Clerk's Office is prepared to accept petitions, and we welcome all those who are interested in taking this first important step in public service," Cunningham said.
